SUMMARY OF EVENT

- 1.1. Vanguardia Ltd was appointed by London Borough of Lambeth (LBL) to provide one acoustic consultant appropriately qualified and experienced to monitor the offsite sound levels (and onsite if required) at the SW4 Festival held on Clapham Common on Saturday and Sunday August 26th /27th and House of Common Event on August 28th, reporting any exceedances of the premises licence criteria to the onsite event manager. Vanguardia were not controlling or managing the sound levels.
- 1.2. We were advised that the following criteria applied to this event:-
 - This is under the 2016 LBL Guidance for Events with added points for monitoring
 - Event was open from 11:00 23:00hrs (Saturday), 11:00 22:30 (Sunday and Monday)
 - Three Spires Acoustics are the Acoustic Consultants
- 1.3. The 2016 LBL Noise Guidance is shown in Appendix A.
- 1.4. A summary of the premises licence conditions and planning consent noise control conditions are as shown below in Table 1:

Maximum Sound Levels and Sound Level Monitoring Locations for the London Borough of Lambeth


The maximum sound levels outlined below are intended to be used for a maximum of 8 major event days in the 5 key Parks and Open spaces of the London Borough of Lambeth (Clapham – Clapham Common, Brixton – Brockwell Park, North Lambeth –Kennington Park, Streatham – Streatham Common, Norwood – Norwood Park), only event organisers who have obtained approval agreements in advance will be permitted to operate using maximum sound levels. In the absence of such an agreement, events will be expected to operate at lower sound levels, which will be determined on a case by case basis by EventLambeth Operations in consultation with approved acoustic consultants.

The maximum Music Noise Level (MNL) shall be 75dB L(A) eq 15 minutes (free field) outside any noise sensitive premises.

The maximum low frequency Music Noise Level (LFMNL) shall be 90 dB L(C) eq 15 minutes (free field) outside any noise sensitive premises.
