# Two dead in night of violence in B BY JAMES TWOMEY

Tributes have poured in for two men who were killed in a night of violence in Brixton on Sunday.

Rapper Perm, from a Claphambased Drill group, and a Deliveroo driver, who has been locally identified as Brazilian national Guilherme Messias da Silva, aged 21, were killed following a car chase that ended in

tragedy in Railton Road. Mr da Silva was reportedly making his last delivery of the night at around 7.50pm before one of two cars in a chase collid-ed with him and killed him.

After the crash, Perm got out of one of the vehicles and was chased by a man from the second car. who was armed with a gun when he was shot and killed.

The Met are still yet to officially confirm the identities of the

two victims, and so far no arrests have been made.

Boxer Dillian Whyte shared a post on Instagram from a friend, Dean Whyte, whose son is believed to be Perm.

Mr Whyte said in the post: "RIP my boy, daddy loves u. Life has changed forever."

Another message posted to Dean's Instagram account on Tuesday said: "Just wanna thank you all for your messages and support. Can't get through all of the messages at this time but just know its appreciated (sic). "Hearts forever broken. Love

you my boy." Perm was a member of the CT

### Woman stabbed to death in Lewisham is named by police

The Met have named a woman who was stabbed to death in Lewisham on Tuesday afternoon. The woman has been identified as 32-year-old

Keisha Christodoulou. Leon Murray, 33, of Tanner's Hill in Lewisham, has

been charged with murder and was due to appear in custody at Bromley Magistrates' Court yesterday.

Police were called to Tanner's Hill at around 3.40pm on Tuesday after concerns were raised for the welfare of a woman at an address there.

Ms Christodoulou was found with stab wounds. ~Despite the efforts of the emergency services, she

was pronounced dead at the scene. Her next of kin have been informed and are being supported by officers from the Met's Specialist Crime

Command. The Met confirmed the victim and the defendant

- 2. The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A23 Purley Way.
- 3. The effect of the Order will be to prohibit any vehicle from:
- (1) entering, exiting or proceeding in a southerly direction on Purley Way between its junctions with Lombard Roundabout and Beddington Farm Road, local access will be maintained between Lombard Roundabout and Miller Road;
- (2) entering or proceeding in a southerly direction on Ampere Way between its junction with Faraday Way and Purley Way southbound;
- (3) entering or proceeding in a westerly direction on Miller Road between its junctions with Thomson Crescent and Purley Way, local access will be maintained between Thomson Road and Euston Road;
- (4) entering or proceeding in a southerly direction on Thomson Crescent between its junctions with Euston Road and Miller Road, local access will be maintained.

Works will be phased such that some restrictions will apply only at certain times

The Order will be effective at certain times between 14th November 2022 and 14th May 2023, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

#### 4. The prohibitions will not apply in respect of:

- (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
- (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London
- 5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs via Lombard Roundabout, Mitcham Road, Roman Way, Old Town, Davenant Road, Duppas Hill Road and Stafford Road to normal route of travel.

2023 Spring and Summer Events The London Borough of Lambeth is applying to the Secretary of State for Environment, Food and Rural Affairs for consent under Article 12 of the Greater London Parks and Open Spaces Order 1967 to carry out restricted works on Streatham Common. The Planning Inspectorate will decide the application on behalf of the Secretary of State.

The proposed works are for the creation of temporary event sites on Streatham Common for a series of public entertainment, recreation and leisure events in spring and summer 2023. Temporary fencing and event structures (including funfair rides and amusements, big top style tents, marquees, concession stands, catering units, gazebos, toilets and welfare facilities, back of house and staff cabins and plant enclosures) will be onsite for the events for a total duration of 47 days in 2023

Temporary fencing will be located at areas on the western side of the common, typically set aside for public events. An event site area will be a maximum of 26,120 square metres at any one time, no more than 10 percent of the common.

Use of heras style fencing will be a maximum of 700 Use of heras style fencing will be a maximum of 700 metres in length and 2 metres in height for two of the four temporary onsite events. The temporary fencing will safely enclose the temporary event sites and will include public and staff entrances, including fire exits. Use of a decorative arch fencing will be used for one of the four temporary events, this decorative fencing is 70m in length with the remaining 400 metor force line height. length, with the remaining 400 meter fence line being standard 2 metre high heras fencing. Pig iron fencing for one of the four onsite events is proposed to enclose two separate areas measuring a maximum of 100m x 75m and 50m x 50m.


