'Cops left blood over my house after raid'

MAN CLAIMS HE WAS NOT ALLOWED BACK FOR DAYS AFTER BRIXTON KILLINGS

A man's house was allegedly left ruined by police officers after they broke down his front door to raid the property following a shooting.

Keith Morton, who lives in Railton Road, Brixton, claims he had his home trashed by Met officers as they hunted for the shooter of Lemar Urquhart, 27, who was killed on October 30.

Mr Urguhart was killed right outside Mr Morton's house and the police searched the immediate area

to find his killer. Mr Morton was not

in the property at the time. The shooting followed a car chase which saw Mr Urquhart crash his white MG into Deliveroo driver Guilherme Messias Da Silva, 23, and kill him.

A cordon was set up blocking access to Mr Morton's house and other houses in the area.

Once the cordon had been removed and Mr Morton was allowed to return to his property five days later, he claims he found
