#### 1.3 Form 1 - Agreements, Transfers and Exemptions

##### a) Agreements for the addition or removal of land to the registered common

There are no agreements in place with respect to Streatham Common having the effect of adding land to, or taking it from, the current registration area.

## **b) Agreements regarding registration responsibilities**

There are no agreements, including straddling agreements, whereby registration duties have been transferred to any other agency. LB Lambeth remains the sole body responsible for registration duties regarding Streatham Common.

There are two (2) leaseholds attached to the registered common, but none of these affect the duty of LB Lambeth as the sole registration authority.

## **c) Exemptions or exclusions relating to common land**

There are no areas of land on Streatham Common which are excluded from the registered common since the common was first designated through the Metropolitan Commons Supplemental Act 1884.

## **2. Register Map**

There are two (2) maps attached to this register, each of which indicate the land registered as common land on Streatham Common (register units). Each map is scaled and titled, with a legend, and oriented to the north.

The first attached register map on Page 4, titled 'Streatham Common – Common Land', identifies the extent of land registered as common land, with the land registered edged in DARK GREEN.

A second attached register map on Page 5, titled 'Streatham Common – Common Land', further clarifies the location and extent of land registered as common land, by showing the land registered coloured in GREEN and also edged in DARK GREEN.

## **3. Individual Register Units**

### **Form 2 - Land Section (Ownership of land attached to the register)**

The attached Form 2 describes the ownership of land registered as part of Streatham Common, including name and address of ownership, title register(s) and any other relevant particulars.

These are shown on the attached register maps on Pages 4 and 5, which are both titled 'Streatham Common – Common Land'

### **Form 3 – Rights Section (Rights of common attached to the register)**

The attached Form 3 describes the rights of common that can be used over the land as described in Form 2 (Land Section) and shown on the attached register maps on Pages 4 and 5.

There are at present no known existing rights of common over any of the parcels of land included in Form 2 and which are part of the registered common. This means there are no supplemental maps attached to this register which show any rights of common or dominant tenements attached to the common.

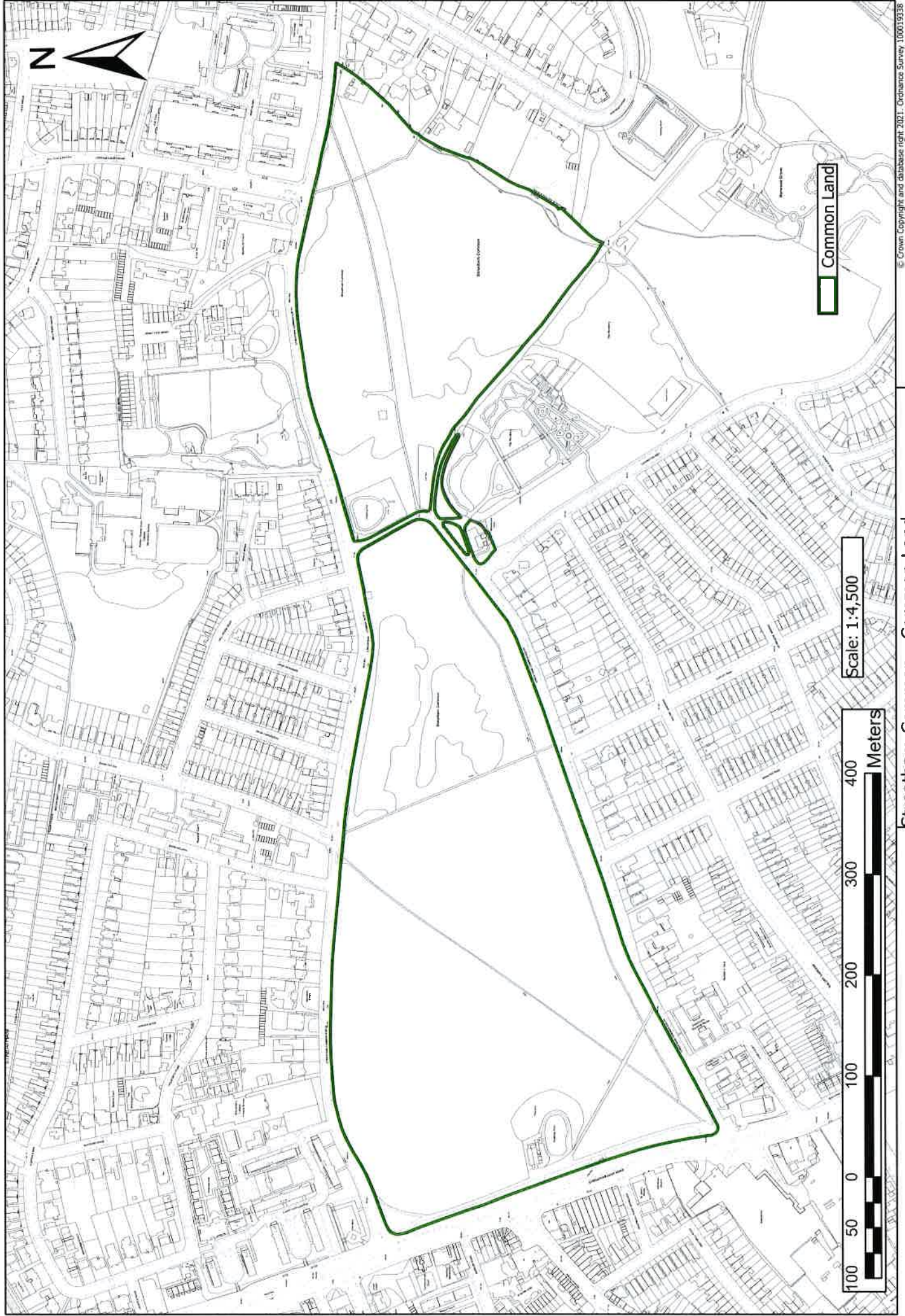

Scale: 1:4,500

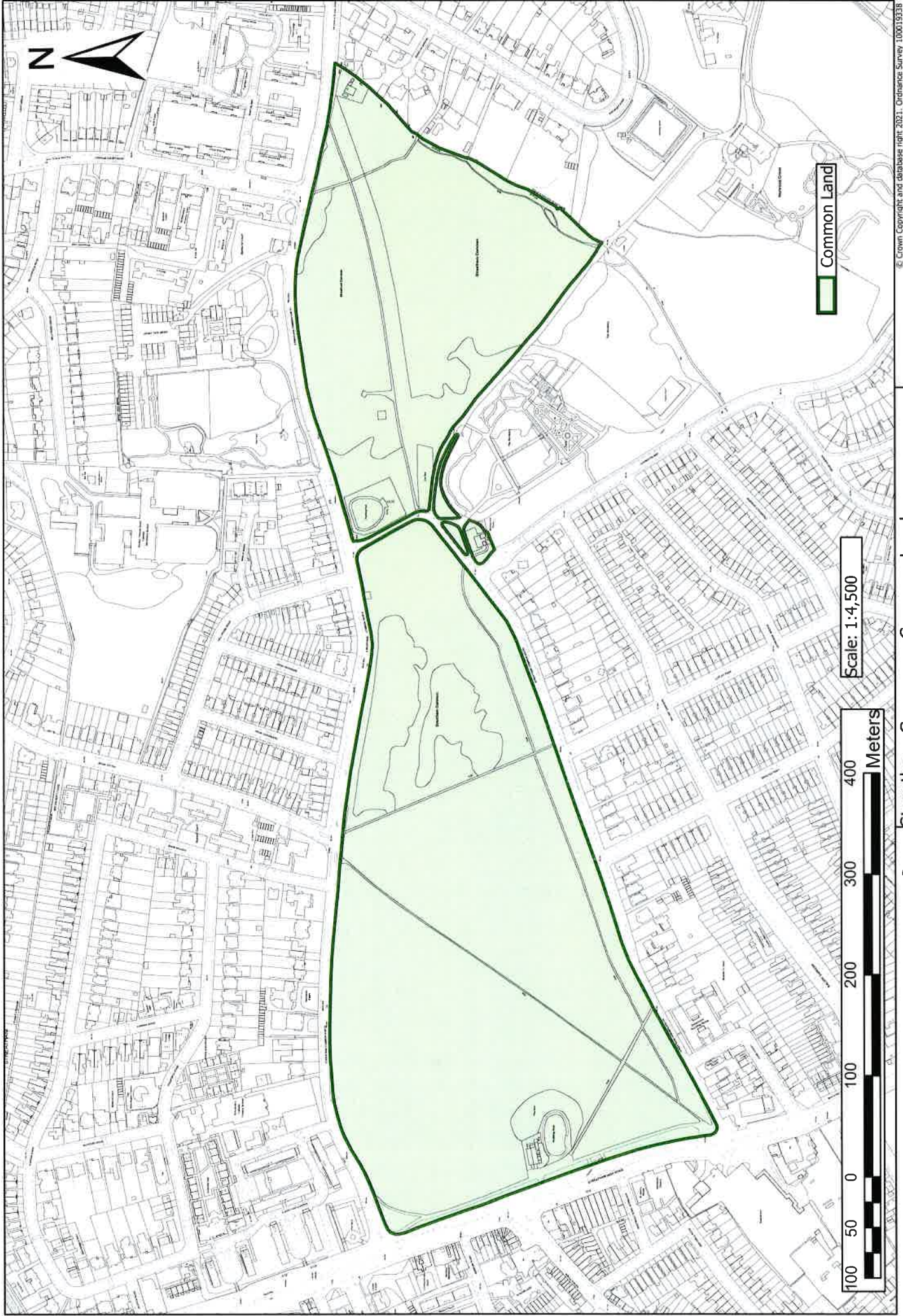
