# 'There are schools that are crumbling'

Teachers across South London joined a national day of strike action on Wednesday as schools closed and thousands made their way to the centre of the capital for a rally.

The day of action, organised by the National Education Union (NEU), was called by teachers demanding pay in line with inflation, properly funded schools and better working conditions.

More than 100 people gathered outside Glass Mill Leisure Centre in Loampit Vale, Lewisham,

before heading into central London to join the national rally.

NEU branch secretary Kim Knappett, who has taught science at Forest Hill school in Dacres Road for 22 years, said her pay had gone down by 23 per cent in the past decade, when inflation was taken into account.

"I'm seeing so many younger professionals leaving so quickly because pay does not match other jobs," she said. "Pupils are being taught by supply teachers or unqualified teachers. It's a tragedy and it's having a detrimental effect on their education."

## Cost of living leads to more sleeping rough

The number of rough sleepers in London has jumped by 21 per cent in a year, as rising bills force hundreds more people on to the city's streets.

London Mayor Sadiq Khan said the figure was "extremely concerning, and further evidence of the devastating fallout from the cost-of-living crisis".

The newly-released figures for rough sleeping in the capital, which span October to December 2022, were published by City Hall on Tuesday morning.

A total of 3,570 people were recorded on the streets by outreach teams in that period, up from 2,949 people in October to December 2021.

The highest numbers were found in the City of London, Westminster and on the South Bank, with high concentrations also seen in Woolwich, Stratford and at Heathrow.

The data shows that there were 1,700 new rough sleepers this year - 29 per cent more than in the same three-month period last year.

The Planning Inspectorate will decide the application on behalf of the Secretary of State.

The proposed works are for the creation of a temporary event site on Streatham Common for a 2-day ticketed public music and entertainment event called 'AfriFest' in September 2023. Temporary fencing and event structures (including an event stage, concession stands, marquees, toilet and welfare facilities, back of house cabins and plant enclosures) will be onsite for a duration of 10 days.

Temporary fencing will be located at areas on the western side of the common, typically set aside for public events. The event site area will be 24,000 square metres at any one time, under 10 percent of the common.

The solid steel shield fencing will be up to 3.4m in height and 730m in length around the whole event site. There will be external trackway at 750 metres to protect the ground. Interior fencing with comprise of 50m of Heras to give privacy around toilet blocks, screen backstage etc.
